SUBJECT OF ORDER – GENERAL DESCRIPTION

1. Description of order: Delivery of Press for surface printing

2. Type of order:
Delivery.

3. Technical parameters of order:

The subject of order is invitation to tender for delivery of machine - Press for surface printing (code CPV 42636100-4 Hydraulic presses)

4. Technical parameters (minimal ones in common):

- Traverse, plate dimensions - min. 1300mm x 1300mm
- Pressing power - from 500-5000kN
- Stroke of moving table - 620mm
- Passage between colons - 1320mm
- Pressing speed - 0-6mm/sec
- Engine power - 15kW
- Ascent speed - 100mm/sec
- Control panel
- heating system for upper and lower plate
- photoelectric barrier - 2 pieces
- CE certifications, manuals, declarations etc.
- CE plate.

Additional services included in offer:

- Test before machine delivery,
- Machine installation and start up.

All additional costs excluding the price of machine e.g. transport costs, installation, start up, customs costs etc. – on supplier side.

OTHER INFORMATIONS (ESPECIALLY LAW, ECONOMICAL, FINANCIAL AND TECHNICAL)

1. Description of tender conditions:

- 1.1. Participants have to possess all necessary funds which will allow right and in accordance with the deadline implementation of order. Have to possess all necessary experience and knowledge to implement the subject of contract. Enclosed Annex no 1 is the example of Declaration.
- 1.2. From the tender are excluded participants who have capital or personal connections with contractors. As a capital connection we understand: connection between ordering company, its authorized persons or other indicated by ordering company to proceed the process of tender and offer choosing from one side and from the other possible contractor which especially consist of: 1). Be a partner in a solo trade company, partnership company, 2). To possess min 10% of company shares, 3). To be on position in company supervising member, management member, plenipotentiary or proxy, 4). To be in state of being married, first/straight family connections, family connection of second line or side line, custody, protection. Declaration has to be attached to the tender offer according to enclosed Annex no 2.

2. Way of offer preparing, terms and place of offer submit:

- 2.1. Complete offer should have:
 - a. name and company address, tax identify number, Bidder telephone contact,
 - b. detailed description of machine technical parameters,
 - c. machine net price,
 - d. the price-offer should include all obligations, should be indicated in EUR or PLN. To compare offer indicated in different currencies, the price will be calculated according to National Bank of Poland medium rate with the date of day preceding the day of offer's opening. The price indicated in offer should cover all the costs connected with its preparing and realization of order. The price can be only one for the subject of tender. We do not allow any optional offers. The offered price is valid for the whole time of offer validity and contract implementation,
 - e. term of delivery – maximum delivery term of order (in weeks, starting from order date),
 - f. time and conditions of guarantee,
 - g. service information, with detailed data regarding reaction of supplier in case of machine problem,
 - h. date of contract and validity of offer (min 30 days from the last day of tender),
 - i. conditions and term of payment,



- j. Bidder signature with the personal and company stamp – offer have to be signed by person authorized or other person entitled to represent with power of attorney signed by authorized person (the Power of attorney should be enclosed to the offer),
- k. Bidder statements – according to the Annex no 1 and Annex no 2.
- 2.2. Offer must be submitted till 10.03.2017 till 15:00.
- 2.3. Offer must be submitted in writing in one of the following ways: e-mail address: januszhurec@orizzonte-polska.pl (scanned documents with signature and stamps), post or personally on company address: Orizzonte Polska Sp. z o.o. Kornica, Przemysłowa St. No 3, 26-200 Końskie, Poland.
- 2.4. Offers delivered after date indicated in point no 2.2. will not be considered.
- 2.5. It is possible to prepare offers in polish, english or italian language.
- 2.6. During the process of offers rating, contracting company can demand additional explanations – regarding content of delivered offer.
- 2.7. Each Bidder may submit only one offer.
- 2.8. Partial offers are not allowed.
- 2.9. Optional offers are not allowed.
- 2.10. All costs connected with preparing offer are covered by Bidder.
- 2.11. Implementation deadline of the contract: till 30.06.2017

3. Offer's rating:

Choosing best offer will be based on the following criteria (max quantity of points possible to get: 100):

Name of rating	Points
1. Net price	from 0 to 60
2. Terms of payment	from 0 to 20
3. Guarantee conditions and validity	from 0 to 10
4. Service reaction	from 0 to 10

4. The system of point calculations will be as follows:

- a. Price, LP – lowest given price divided by controlled-analyzed ones and multiplied by 60 points.
- b. Terms of payment, TP, 20 points - 100% of payment after delivery of machine, in case of prepayment till 30% of value – 15 points, in case of prepayment for more than 30% of value - 0 points.
- c. Guarantee, G, 10 points if the guarantee will be given for 2 years. 1 year guarantee - 5 points. Less than 1 year – 0 points.
- d. Service, S, 10 points in case of reaction till 5 working days. 5 points till 7 working days. 0 points for more than 7 working days.

Contracting company will choose the best offer according to the point balance according to above mentioned name of rating and will sign the contract with chosen company.

Contracting company does not predict the public offers opening.

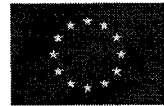
